


- Provide opportunities for streamlining procedures, and updating regulations
- ✓ Improve coordination between Customs, Other Government Agencies and the Private Sector
- ✓ Improve government's revenue collection and data capture capabilities
- ✓ Reduce processing times
- ✓ Reduce trade costs



One Member's Experience


The United States CBP started a project to replace its national customs processing system- Automated Commercial System (ACS) in the 1990s

Several Decades- Many \$ Millions- and a very complex project planning, they now have a modern system that also serves as their Single Window.



Proposed North American Single Window

Canada –US- Mexico shared a proposal /goal - North American Single Window(NASW)

Interoperability will depend on aligning of harmonized data requirements for the various steps in the cross border process.

Role of Customs in the implementation of a Single Window

Regularly engages with the private sector



- Regularly engages with the other CBRA
- Trade Facilitation generally involves procedures handled by Customs
- Successful SW : include cross border procedures combined in a more efficient automated platform, reduces duplication, is faster, and more efficient

Findings of WCO 2011 & 2016 surveys-overwhelming majority of Single Window systems are managed by the Customs or Revenue Authorities
